## **APPLICATION**

This application depends on the discretion of the Porterville show committee. Prove of payment must be mailed with your application form. Refunds will only be dealt with in extreme circumstances. Specify additional needs i.e. (electricity and water).

### **CLOSING DATE:**

Applications will be handled on a **first come, first served** basis. All stall fees **must** be paid by 12 August 2022.

### **APPLICATION REGULATIONS:**

**All exhibitions must be up and running at 09:00am on Friday 26 August, (No exceptions). Late comers will be allowed to enter the premises but will be black listed for future events and will pay a fine if not arranged beforehand on condition.**

**Exhibitions will not be allowed to remove their exhibitions before Sunday 28 August 2022 at 15:00.** Stalls open at 8:00am and are not allowed to close before 17:00pm. They can remain open later at own free will. Fellow exhibitors must be respected at all times taking into account the locations and placement.

**Only one power point per exhibitor. Exhibitors are responsible for their own extensions and it must be in good working order.**

### **FIRE EXTINGUISHERS ARE COMPULSORY FOR ALL EXHIBITORS:**

All health and other safety regulations as prescribed by the Bergrivier Municipality must be adhered to.

No sub-letting of stands is permitted. Porterville Show will not be held responsible for any agreements between exhibitors. Right of admission reserved. The Show committee has the right to remove any exhibitors guilty of misconduct, from the grounds.

The Show committee is not responsible for the exhibitor's products not selling. The stalls must be running for the full period of the show, there will be no exceptions

The Committee will do anything in its power to enforce safety regulations during the period of the show, but it cannot be held responsible for any lost, theft, damage or injury. The Show grounds are fenced in with 24 hrs. Security in attendance. No additional security will be posted at exhibitions. Exhibitors exhibit at own risk.

Exhibitors are not allowed to sell anything that is not declared on the application, and there for the Committee is allowed to remove such items or have it removed.

**No tables or chairs will be provided.** Exhibitors are responsible for the building their own stalls, no help will be provided. Exhibitors are not allowed to extend their borders. No paint on permanent walls or structures or nails or any such things that can cause damage are allowed. Exhibitors are responsible for their staff's behaviour. Only 2 entry bands per stall. Additional bands will be sold at the office at the normal daily tariff. **Any exhibitors or assistants without an entry band will be escorted from the show grounds immediately.**

### **THE SELLING OF BB GUNS AND OTHER DANGEROUS PRODUCTS WILL NOT BE ALLOWED**

Exhibitors are allowed to start building their stalls on Thursday 25 August 2022 from 8:00am. Exhibitors will pay a fee of R150.00 per day if entry to the show grounds is gained earlier than 25 August 2022..

Only one vehicle will be allowed on the Show grounds. No vehicles will be allowed without a parking ticket. These vehicles will only be allowed at the stalls from 07:00am to 08:00am and then from 18:00pm to 19:00 for transporting stock.
